Building this understanding will better ground learners in future studies of the stock market, investment analysis, and investing strategies.

In the Introduction to the Stock Market class, learners will find the answers to the following questions:

- 6. How do you measure stock market health?

Understanding the structure of the stock market allows learners to better understand its contribution to many investment strategy outcomes.

<u>Prerequisites</u>: Learners should have the following knowledge: a simple understanding of investing, how a business makes money, what is a stock, and how the stock market works.

In the Stock Investing: Understanding Stock Information class, learners will explore the following topics:

- 1. Stock Tickers
- 2. Stock Statistics
- 3. Placing a Trade
- 4. Reading a Stock Chart
- 5. Discovering What Moves Stock Prices

There will be a case study to illustrate how to read and interpret stock movements. Although a segment of investors relies on charts and technical analysis to make their investing decisions, the case study and class provide several perspectives. My teaching philosophy is to help learners understand why the information is important and how it can be used (sometimes in multiple ways). With the knowledge from this class, learners are better prepared to research stocks and continue their studies in stock investing.

<u>Prerequisites</u>: Learners should have the following knowledge: an understanding of investing, what is a stock, how a business makes money and competes.

In the Stock Investing: Understanding Risk class will explore the following topics:

- 4. Risk: Static or Dynamic?
- 5. Risk vs. Reward
- 6. Managing Stock Portfolio Risk

The case study follows a company's journey in risk and provides a real-world example. My teaching philosophy is to focus on broad principles and key takeaways of risk and risk management. Learning about risk will better ground learners in the complexities of investing.

1.4: STOCK INVESTING: UNDERSTANDING INVESTING STYLES

<u>Prerequisites</u>: an understanding of investing, what is a stock, how a business makes money and competes, awareness of what moves stock prices, and a casual understanding of stock investing risks.

The Stock Investing: Understanding Investing Styles class will introduce learners to a broad range of investing styles:

- 1. Analysis: Fundamental (Growth & Value) vs Technical
- 2. Approach: Top-Down (Macro) vs Bottom-Up (Micro)
- 3. Information Processing: Qualitative vs Quantitative
- 4. Time Horizon: Short vs Medium vs Long
- 5. Temperament: Aggressive vs Defensive

During the lesson, there will be a case study to dissect a famous investor's style. My teaching philosophy is to show the breadth of stock investing styles and their key takeaways instead of detailing individual style strengths and weaknesses. Building this foundation will better prepare learners for future studies in specific investing styles and learning about other famous investors.
